If not claimed within ten days, vehicles will be sold to the next highest bidder. Any interested person may bid on the vehicles. Prospective bidders may make arrangements to view the vehicles by contacting the Platteville Police Department at (608) 348-2313. Payment is to be made prior to removal of the vehicle. The City of Platteville reserves the right to reject any and all bids if deemed to be inadequate. Purchasers of the other vehicles will be provided with receipts which may allow for titling through the State of Wisconsin. For all vehicles, interested persons should understand that these vehicles have been abandoned by their owners.
