## **OFFICIAL NOTICE TO CONTRACTORS**

Notice is hereby given that sealed bids will be received up to 10:00 a.m., Tuesday, August 1, 2023 in the Office of Director of Public Works, Municipal Building, 75 North Bonson Street, Platteville, WI 53818 for the following work, at which time and place all bids shall be publicly opened and read.

### **Contract 8-23 HIGHWAY PAINTING**

All bids shall be addressed to the Director of Public Works, Municipal Building, 75 North Bonson Street, Platteville, WI 53818, with the name and address of the bidder, contract number and title of work distinctly indicated on the outside of the envelope.

Contract documents together with plans and specifications for this project are on file for examination and may be obtained after July 10, 2023 in the office of Director of Public Works, City of Platteville. A non-refundable deposit of \$5.00 is required for shipping.

Sealed bids must be accompanied by a certified check or bid bond payable to the City of Platteville, Wisconsin in the amount of not less than five (5) percent of the total amount of bid as a guarantee that if the bid is accepted, bidder will execute and file proper contract documents, performance bond and insurance within ten (10) days after award of the contract.

When the intended awardee so executes the contract agreement and files bonds and insurance as required by the contract documents, the check or bid bond will be returned.

In case the intended awardee fails to execute the contract agreement and file bonds and insurance as required by the contract documents, the amount of the check or bid bond submitted with the contractor's proposal shall be forfeited as liquidated damages.

All bids shall be made out on the proposal forms furnished by the City of Platteville in the contract documents. Any alteration or extension of the form or the furnishing on it of unsolicited information may cause the bid to be declared informal and result in its being rejected.

No bid shall be withdrawn for a period of thirty (30) days after the scheduled time of opening bids.

The City of Platteville reserves the right to reject any or all bids, to waive any informalities in bidding, or accept the bid deemed most advantageous to the City.

**SPECIFICATIONS**

Any and/or all of the following documents that are applicable are included in the Specifications for this contract:

1. Traffic Controls for State and Highway Construction and Maintenance Operations, Part VI, of the U.S. Department of Transportation, Federal Highway Administration's Manual on Traffic Control Devices for States and Highways.
2. The following portions of the Municipal Code of the City of Platteville:
  - a. Chapter 4, Streets, Alleys, and Sidewalks
  - b. Chapter 23, Building Code

Copies of the above documents are on file in the office of the Director of Public Works.

Whenever there is a conflict between the construction plans and the specifications as outlined in the Instructions To Bidders, the plans shall govern. The Special Provisions shall govern if they are in conflict with either the plans or the specifications.

DESCRIPTION OF WORK

This project consists of painting centerline stripes, stop bars, crosswalks, words and symbols on selected streets in the City of Platteville. This is a re-paint of existing lines.

MATERIALS

- A. Paint used shall be Epoxy, applied at 15mil thickness with glass beads applied at the rate of 25 lbs per gal of paint.
- B. Any oil or water base paint residue, whether stripes or symbols, that will restrict or limit the adhesiveness of the Epoxy paint shall be removed, either by sand blasting, grinding or any other method that is first approved by the City of Platteville.
- C. All crosswalks, turn arrows, stop blocks, words or symbols shall be repainted using the Epoxy paint.

CONSTRUCTION

Suitable methods shall be used to protect the public and the uncured paint from traffic. Any damage to the uncured paint will be the responsibility of the contractor. For clarification of the responsibilities, the contractor shall place signs, barricades and/or personnel in accordance with the MUTCD to ensure traffic does not interfere with the paint application process or damage the paint before it is properly cured.

BASIS OF PAYMENT

Highway Centerline 4" Double Yellow: The contractor shall apply 2 each 4" wide yellow lines with payment per linear foot of the double line. Each line shall NOT be paid separately.

Stop Block: Each stop block shall be 18" wide white line from the edge of the pavement or gutter to the centerline as determined by the City. Payment shall be per linear foot of 18" line applied. These will be on the five (5) side streets – Northside Drive, Fairfield Drive, Pitt Street, Kase Street and Sowden Street.

Crosswalks: Crosswalks shall be composed of 4" white lines – 2 are perpendicular to the direction of traffic from one side of the street to the other. The contractor shall be paid for the linear foot length from one side of the intersection to the other for each crosswalk.

YIELD: The word YIELD to be applied in designated locations per MUTCD guidelines. Payment is for the entire word per occurrence.

4" Single White Skips – Yield: The contractor shall paint white dashed lines at the yield locations at the roundabout. Payment is per linear foot of white dashed line

4" Single White: The contractor shall apply 1 each 4" wide white line with payment per linear foot of the single line. These lines shall be paid for channeling and lane markings along the edge of the splitter island along the outer ring of the roundabout circle.

Crosswalks - Roundabout: Crosswalks shall be composed of 8" white lines parallel with the direction of traffic. The contractor shall be paid for the linear feet of crosswalks from each side of the intersection to the splitter islands.

4" Yellow on splitter islands: The contractor shall apply 4" wide yellow line with payment per foot of the single line. These lines shall be paid for channeling and lane markings along the edges of the splitter islands.

Nose: The contractor shall apply yellow epoxy paint to the nose of each island in the roundabout. Payment is for the nose per occurrence.

4" Double Yellow with diagonals (north and south): The contractor shall be paid for repainting the 4" double yellow lines as they split upon approaching the splitter islands from the north and south, including the 4" diagonal lines between the double yellow lines. All work to repaint these lines shall be paid per occurrence.

4" Single Yellow with diagonals (east and west): The contractor shall be paid for repainting the 4" single yellow lines as they split upon approaching the splitter islands from the east and west, including the 4" diagonal lines between the single yellow lines. All work to repaint these lines shall be paid per occurrence.

### **Alternate Bid**

Crosswalks: Crosswalks shall be composed of 4" white lines – 2 are perpendicular to the direction of traffic from one side of the street to the other. These shall be new crosswalks, not repainted. They will be paid per linear foot from one side of the intersection to the other. The new crosswalks shall be parallel to State Highway 80 (Water Street) on side streets – Northside Drive, Fairfield Drive, Pitt Street, Kase Street and Sowden Street.

### **EQUIPMENT**

All equipment, tools and machines will be subject to the approval of the Director of Public



Works. The contractor shall provide all equipment to clean the pavement prior to application, epoxy paint, paint applicators and auxiliary equipment to perform all work.

### COMPLETION

Time of completion for this project is October 31, 2023. Completion means that all work, including clean up, has been accomplished. This location is adjacent to the High School. Students are expected to be present in late August.

All work must be completed within 5 working days of starting work, unless there are weather delays. This may be scheduled at the Contractor's Discretion beginning at the Notice to Proceed date. The Contractor is required to notify the City of Platteville Street Department (608) 348-8828 at least 2 business days prior to starting work.

## INSURANCE

Contractor shall provide certificate of insurance for the following required coverages.

1. Comprehensive General Liability Insurance - with bodily injury coverage of not less than \$1,000,000 each person and \$1,000,000 each accident and property damage coverage of not less than \$1,000,000. Comprehensive General Liability to include premises and operations. Contractor's protective liability, products liability including completed operations coverage and contractual liability.
2. Personal Injury - false arrest, detention or imprisonment or malicious prosecution, libel, slander, defamation or violation of right of privacy, wrongful entry or eviction or other invasion of right of private occupancy to be included.
3. Comprehensive Automobile Liability Insurance - with bodily injury coverage of not less than \$500,000 each person and \$1,000,000 each accident and property damage coverage of not less than \$500,000. Comprehensive Automobile Comprehensive Automobile Liability to include all owned and non-owned automobiles.
4. In lieu of the above limits, a single limit policy in the amount of \$2,000,000 or a \$2,000,000 Umbrella is accepted.
5. Bodily Injury Protection - under both comprehensive general and comprehensive automobile forms shall be on an "occurrence" basis.
6. Worker's Compensation – per State statutes.

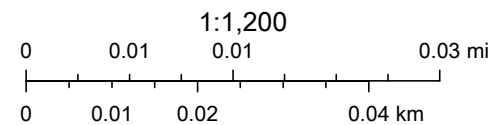
# Madison-Water Roundabout
